Vision Statement

Uniform matters because it shapes our attitude to learning every day. Wearing uniform supports inclusion by ensuring everyone is equal, valued, and visibly part of a shared community. It encourages pride in belonging, reinforces our collective identity, and reflects respect for the school environment we learn in. By taking a strict and consistent approach to uniform, we help pupils develop habits that extend beyond the school gates, responsibility, self-presentation, and pride in contributing positively to the school community. Our uniform represents who we are, and the standards of excellence that we uphold together.

Aims of School Uniform Policy

- To reflect the school's high expectations and the pride that is taken in wearing school uniform and dressing appropriately for school
- To develop a sense of belonging and school identity for all members of our school community
- To help children arrive in school physically, emotionally and socially ready and able to learn
- To promote a socially inclusive and equal environment by minimising the competition to wear branded clothing and footwear.
- To ensure that school is a neutral environment, free from political or ideological agenda

Our Uniform:

- Plain red sweatshirt or cardigan with Humberstone school logo (available to buy from the supplier):
- Plain grey trousers or plain grey skirt or pinafore dress. (Plain black leggings may be worn only underneath a skirt or pinafore for religious reasons)—no jeans, leggings, jogging bottoms or denim material trousers.
- Skirts and dresses must be of an appropriate length
- Plain white shirt or polo shirt (must have collar) with no graphics or logos other than school name and logo
- Plain black school shoes. No trainers, no heels or flip flops. Plain dark coloured sandals may be worn in the summer. Plain black or dark brown boots may be worn in the winter

Summer options:

- Grey tailored knee length shorts
- Red Gingham dress

PE Kit:

For health and safety reasons it is essential that children are appropriately dressed for any physical activity. PE kit should be available in school for every PE lesson. Children and parents will be informed in advance what days the PE kit will be needed for. PE kit should be

plain and unbranded, without logos or slogans of any kind.

- Plain black shorts. Plain black leggings may be worn, for religious reasons where this is requested.
- Plain white t-shirt – not the same shirt that has been worn during the day, no logos or slogans
- Black plimsolls for indoor P.E. Trainers may be worn for outdoor P.E
- Plain black or grey hooded top, fleece and jogging bottoms may be worn in winter months, no logos or slogans
- A school P.E kit is available to buy online
- All items must be stored in a small cloth or nylon P.E. bag which is available to buy online

Jewellery:

For health and safety reasons children are not permitted to wear jewellery in school. Children who have pierced ears will be permitted to wear plain studs which must be covered with tape during P.E or other active lessons which is in keeping with health and safety guidance for schools. We recognise that children may need to wear an item of jewellery for religious reasons and that this is a cultural and religious need that should be respected. Piercings in other areas for decorative reasons are not permitted. **All piercings will need to be removed or covered up during P.E. and swimming lessons.**

Please support us in not allowing pupils to bring jewellery to school especially as children often become very upset if a piece of jewellery is lost or damaged during the school day.

Please note that the school is unable to take responsibility for the safekeeping of any items of jewellery throughout the day.

Make up/ Hair:

Children are not permitted to wear makeup to school. This includes nail extensions, nail polish, false eyelashes, stick on tattoos, and other similar items. Children's hair must be kept neat and tidy. It is advisable for children with longer hair to tie it back for school for health and safety reasons. **Extreme haircuts, shaved hair designs, dyed colours, coloured hair extensions etc are not appropriate for school and are not permitted.**

Safeguarding:

The school has a duty to safeguard and promote the welfare of all its pupils. Children will be expected to wear school uniform at all times, which means that children are easily identifiable within the school and when outside in the community.

The school also has a responsibility to protect pupils and their families from the pressure to wear expensive or high fashion items and to promote a cohesive environment. Wearing school uniform helps to minimise social pressures, promotes harmony between different groups within the school and reduces instances of bullying and social exclusion based on appearance.

Race Equality/ Equal Opportunities

The Trust Board and school staff have a duty to ensure that all pupils are treated equally and that any disadvantages are addressed. The wearing of school uniform is an essential part of promoting equality and building a positive learning community that is free from discrimination, social pressures and political agendas.

The school will respect variations to the uniform policy if they are directly in relation to religious, cultural or medical reasons. Variations will be dealt with on an individual basis and judgements will remain the discretion of the Senior Leadership Team. Parents who are not financially able to provide school uniform for their child may be eligible for support with this and should contact the school office.

Role of the Class Teacher and Support Staff

All staff have a crucial “leadership” role to play in school and should act as positive role models for children, promoting the ethos and vision of the school at all times. It is expected that:

- Staff set a good example and dress in a smart and appropriate manner (no jeans, leggings or tracksuits unless leading sporting or practical activities)
- Address issues with children when the uniform policy is not being adhered to considering the age and maturity of children
- Promote the uniform policy at all times in their interactions with parents, pupils and in the wider community
- Act as ambassadors for the school in both conduct and appearance

Role of the Senior Leadership Team and Trust Board

The Senior Leadership Team and the Trust Board have a crucial role in working together to ensure that the school uniform policy reflects the ethos and values of the school and is adhered to by staff and children. It is expected that:

The SLT will address issues of non-compliance with uniform policy with pupils and their parents as part of maintaining the day to day discipline of the school

Leaders have a duty to promote the uniform policy at school events, through school publications and communications, as part of the induction process and in individual dealings with parents

School leaders and the Trust Board have a duty to listen to any reasonable complaint from parents/carers or staff concerning the implementation of the uniform policy and work with parents to help communicate expectations clearly and fairly

Role of Parents and Carers

Parents have a crucial role to play in ensuring that their children arrive at school ready to learn. Wearing of the agreed school uniform is considered an important part of learning readiness and supports the school ethos. It is expected that parents:

- Ensure their child is dressed in line with the agreed uniform policy unless there are special and exceptional circumstances that prevent this

- Engage positively with the school when issues arise regarding the school uniform policy

Non- Compliance with the school uniform policy

Parents will be well informed in advance of joining the school that the school uniform policy is compulsory. The uniform policy will be regularly reviewed, updated and made available to parents through the school website. Where a child does not follow the agreed policy, the following actions will be taken in the following order

- 1) Discreet and gentle reminder to the child that they need to wear the appropriate uniform taking the age and maturity of children into account. Discreet reminder to parents and carers from class teacher that the child is not wearing uniform and if necessary a reminder of the correct uniform
- 2) Verbal reminder from Senior Leaders to parents/carers that their child must wear the agreed school uniform. Parents invited to discuss any difficulties they may be having in providing the correct school uniform
- 3) Written reminder to parents/carers that their child must wear agreed school uniform and warning that non-compliance may result in their child being asked to go home to change

Where a pupil is not adhering to the school uniform policy, the school will be considerate and discreetly try to establish why not. There may be good reasons why a pupil is not attending school in the correct uniform. For example, their uniform may have been lost, stolen or damaged. If a pupil is not wearing the correct uniform because their parents are in financial difficulties, the school will be sensitive to the needs of the pupil. The school will give parents time to purchase the required items or the school will provide the correct items of clothing where this is appropriate. Pupils will not be made to feel uncomfortable, nor discriminated against, if their parents are unable to provide them with the required items of school uniform. In cases of persistent non-compliance with the agreed uniform policy, where attempts at financial and other support have been exhausted, parents may be called to collect their child from school and ensure they are returned in the correct uniform.

Hardship Fund

If parents are experiencing difficulties in providing the correct uniform they should contact the school office. Any request for help will be treated sensitively and where possible, the correct items may be provided.
